



RULES

My Anniversary Stamp

SUBMISSIONS

Participants:

- Only individual pupils can submit contributions; no group submissions will be accepted.
- There is a limit of one entry per pupil
- Only registered primary schools can participate.
- All entries must be submitted through the portal.

Timeline: Pupils can start their activities now and upload them between 26 March and 9 May 2007.

Languages: Mother tongue - and translation into English, French or German.

Submission: Picture (artwork) of a stamp with a name (title).

Size of contributions:

- Picture image files – jpg, gif
 - Max. 800 pixels wide
 - Max. 600 pixels long
 - 3 MB
- Text
 - Max. 100 characters in mother tongue
 - Max. 100 characters in English or French or German

EVALUATION CRITERIA

All evaluators and judges will give a score to projects based on the following criteria:

- ***Creativity and originality:*** Contributions should represent and reach the age group of the competition. They should demonstrate significant originality and initiative in concept, style, layout and design.
- ***Clarity of the message:*** The contribution should have a strong visual impact, a clear and relevant message and demonstrate an understanding of the addressed theme. The message expressed in picture and slogan should be related to each other.
- ***Quality of the contribution:*** General artistic quality criteria (layout, composition, style, colour, etc.) are also important.

The judges' selection is final and there is no room for discussion once the selection has been made.

PRIZE

The ten best stamps will be printed in a large-size format and framed. In addition, as the Belgian postal service runs a programme called 'My Stamp' which prints individual designs into real stamps that can be used for postings, the winning pupils will get a set of their stamps in a real stamp format. The large-size stamp and the real stamps will be sent to the ten best entries and they will be highlighted on the portal.

RIGHTS

European Schoolnet and/or the European Commission reserve the right to adapt the rules and awards at any time. Any changes will be notified on the 'Spring Day for Europe 2007' website and will apply from the date of publishing.

Legal and Ethical Issues

- All entries must follow European agreements on copyright. Entries may not contain statements, facts, information or quotations that may harm or diminish any person or group of people.
- Entries may not contain statements, facts, information or quotations that may encourage persecution of people on the grounds of race, opinion, nationality, sex, profession or other persuasion. Nor may entries encourage crime or the breaking of laws.

Disqualification of Entries

European Schoolnet or the European Commission reserve the right to disqualify an entry if it has not been submitted on time, partly or as a whole, or if the entry breaks any of the rules under Legal and Ethical issues.

Reproduction Rights

All entries and submitted material are the property of the European Commission. The European Commission has the right to improve, edit, expand, modify and reproduce the material through the Internet, CD-ROMs or other media as from the date of submission.
